The facility was established in year 2017 and the main business activity of this facility is manufacturing of organic cotton bags.

This semi announced initial small producers assessment was conducted on 08 Dec 2020 and it is 1.0 Man day onsite.

The below are building details:

There are three production sheds and out of which 02 are occupied by the audited facility and has process like cutting, sewing, checking, finishing and packing and dispatch. Another shed was occupied by the landlord in the name of BP Dyeing company and the same was found idle and locked during the day of audit.

The opening meeting was attended by Mr. Devan Patodia – Partner and his Team along with worker representatives. The auditor briefed the management about the audit requirements, the audit process and sought permission to take photographs.

This was agreed to by the management without any reservation. The auditors took a facility tour to establish the health and safety systems prevalent in the facility, prevalence of child labour/young labour, and forced labour.

Closing Meeting:

During closing meeting, the auditor greeted and thanked the management for their co-operation during the audit. The non-conformance found during the audit were explained to the management. The corrective action plan for audit was also discussed and signed. The auditor also invited any feedback from the management regarding the audit process and facility management were receptive to the findings and committed to take corrective action for the findings at the earliest.
