RECOMMENDATIONS

- Storing, operating and transportation: Do not subject the product to sudden temperature fluctuations. Do not store it at extreme temperatures. Do not expose it to open containers outdoors. Shake before use.

- Compatibility: FERTIAMIL has excellent solubility and compatibility to be used as a mixture. Therefore, a small compatibility test should be conducted before mixing with other phytosanitary products or fertilisers.
- Application: Once opened, use the product in the field, preferably within 4 months.
- Classification of the substance or mixture.

The mixture does not contain substances classified as PBT.

The mixture does not contain substances classified as vPvB.

The mixture does not contain any endocrine disrupting properties substances.
