TYPOLOGY:

Type II R surgical mask, single-use, non-sterile, non-reusable

PRECONIZATIONS:

It is intended to prevent, during the exhalation of the wearer, the projection of upper airway secretions or saliva that may contain infectious agents transmissible by "droplets" or "aerial". Worn by the caregiver, it prevents contamination of the patient and his environment (air, surface, products, etc.).

Carried by the contagious patient, it prevents contamination of his environment and surroundings.

This mask protects the wearer from "droplet" transmissible infectious agents, but in no way protects against "airborne" transmissible infectious agents

TIPS FOR USE:

- Single-use, non-reusable mask for up to 4 hours.
- Close the box after use.
- Mask to be discarded after use in a designated garbage can and not in the wild.
- In case of respiratory pathology, dermatological and allergic problem, in case of psychiatric disorder, person suffering from autism disorder and any other adverse effects, please consult a health professional

BEFORE USE:

- Check the box thoroughly before opening.
- Check for moisture or mould.
- Check the box for crushing
- If in doubt, change units or boxes.
- Read instructions and seek advice from a health professional

WARNING: A

- The mask is not designed to protect the wearer from gases.
- The mask cannot be used in an explosive atmosphere.
- -It is unlikely that the sealing requirements of the mask will be met if facial hair passes under the face seal
- Keep out of reach of children.
- Do not use after expiry date.
- Product containing non-woven components, to be used with caution for allergy sufferers.

ADJUSTMENT AND CONTROL OF WATER RESISTANCE:

Adjust the position of the mask so that it covers the face and its contour is as close as possible to the skin.

To check the seal of the mask:

Avoid touching the mask while wearing. Do not place the mask on the forehead or chin in a ready position

- Blow with your mouth to inflate the mask, - If air comes out of the nose, adjust the thread pinch nose, - If air is still coming out after adjusting the nose clip, change the mask. NORMAL STORAGE AND STORAGE CONDITIONS:



Store in a protected location

Do not store in the sun

Store between 5°C and 40°C

Store UV-free


Do not store in a damp, weatherproof location Store in a dry room where humidity is less than 80%

Do not wet the mask before use

Storage conditions should be checked regularly.
